As an accredited GreenPower Provider, Next Business Energy purchases accredited GreenPower LGCs for the % of electricity usage you nominate. We will charge you for Next GreenPower at your nominated %, and then we buy GreenPower accredited LGCs to offset carbon emissions, for the amount you nominate.

## Select your Next GreenPower Percentage

The Next GreenPower % will apply to your usage from your last bill.

#### Next GreenPower Terms and conditions

Next GreenPower charges are in addition to your electricity usage charges. Discounts do not apply to Next GreenPower charges. Concessions or rebates do not apply Next GreenPower charges. Next GreenPower charges are calculated by multiplying the GreenPower rate by the selected GreenPower % multiplied by your recorded energy usage for the billing period.

Next GreenPower does not apply to Demand charges.

Next GreenPower is accredited and audited by the National GreenPower Accreditation Program and subject to its scheme rules.

#### Commencement of Next GreenPower

Next GreenPower charges will commence where we are financially responsible for a site, from the contract start date, or next billing date (for each individual site in schedule 1) after acceptance of this agreement.

#### Variation of GreenPower Percentage

You may request to vary Next GreenPower percentages. Variations will apply from the next billing date following acceptance of a new Next GreenPower agreement.

#### Cancellation of GreenPower

Cancellation of Next GreenPower charges will occur from the previous billing date following receipt of a written cancellation request from an authorised representative.

#### Next GreenPower Price Variations

Next Business Energy may, with prior written notice, vary the Next GreenPower price applicable to this agreement.

#### Next GreenPower Termination

Next Business Energy will continue to charge you Next GreenPower until such time as you cancel this agreement, or until we are no longer FRMP for your site(s) listed in schedule 1.

#### Withdrawal of Next GreenPower

We may withdraw Next GreenPower by providing at least 20 Business Days prior written notice to you.

#### Is your business operating in the ACT?

The ACT government already offsets 100% of emissions from electricity used inside the territory, this is funded through charges that are included in all ACT electricity bills.
